All members applauded this great achievement and the academic council extended best wishes and congratulation to Prof. Dandekar.

Then proceedings were duly conducted by Professor Lalit Purohit, Dean (ARSD), in accordance with the already circulated agenda.

The deliberations of the meeting are as under:

Item No. 1	To confirm the minutes of the 33 rd meeting of the Academic Council held on 10 th July 2025 and the 43 rd meeting of the Standing Committee held on 1 st August 2025, and to ratify the actions taken accordingly. (Annexure I & II)
	The minutes of the 33 rd meeting of the Academic council were approved. The council expressed satisfaction on the presented action taken report.
	Furthermore the resolutions recorded in the minutes of the 43 rd meeting of the Standing Committee were approved with the needful updates in the 1st year curriculum in accordance with the resolutions recorded via agenda item no 3 and 7(VII).
Item No. 2	To discuss and approve the common B.Tech scheme across all branches from 2 nd to 4 th year (Annexure – III) of
	It was resolved that the Dean (ARSD) should constitute a committee to develop a unified framework for all B.Tech. programs for the 3rd to 8th semester, specify a

	comprehensive mandate, and present its recommendations in the next meeting of the Academic Council alongwith the recommendations of respective BOS thereon.
Item No. 3	To approve credit assignment for activities conducted under the course title "Udbhav" started for B.Tech 1 st year student (in line with AICTE Guidelines) (Annexure - IV)
	The credit allocation framework for the course titled "Udbhav", designed for first-year B.Tech students, was formally presented to the house. The council commended the proposed scheme and granted its approval. The house further underscored the importance of incorporating NCC/NSS activities within the purview of the Community Service Committee (CSC) as part of the credit-eligible engagements. Additionally, the CSC was urged to proactively assess and consider community service initiatives voluntarily proposed by students for inclusion under the scheme. Dean(ARSD) was authorized to allow various flexibilities in conducting the Udbhav course and its assessment mechanism as per the experiences gained over the time.

Agenda items A1 and A2 were duly deliberated upon, and it was resolved that the committee constituted under Agenda Item: 2 shall also take into account items A1 and A2 in its recommendations.

(B) Department of Civil Engineering

Agenda Item B1	To discuss and approve the common B.Tech scheme across all branches from II to IV year
B2	To start the UG program in Civil Engineering (Hindi) with the intake of 60 in Hindi medium.
B3	<p>Introduction of New Course or changes in any courses in the existing scheme No new course is introduced, following changes in existing courses are recommended by Board of Studies</p> <ul style="list-style-type: none"> (i) Regarding Undergraduate Programme w.e.f. session 2026-27 (ii) Regarding undergraduate program w.e.f. 2025-26 (iii) Regarding Post Graduate Programme w.e.f. session 2025-26

Agenda items B1 to B3 were thoroughly discussed. It was resolved that the committee constituted under Agenda Item 2 above shall also incorporate Agenda Item B1 in its recommendations. Regarding Agenda Item B2, it was decided that a formal proposal shall be submitted for the introduction of a Civil Engineering (Hindi) program with an intake of 60 students, to seek necessary approval from AICTE. Furthermore, the institute expressed its intent to progressively augment the infrastructure and academic resources within the Civil Engineering department. The recommendations under Agenda Item B3 were reviewed and subsequently approved by the Academic Council.

(c) Department of Electronics and Telecommunication Engineering

Agenda Item C1	The subject "Deep Learning" is approved in the PEC-IV list of B.Tech Electronics and Telecommunication Engineering for Final Year students through the online NPTEL/SWAYAM mode. However the experts emphasized that the Machine learning and Deep learning courses are to be taught in the off-line mode, preferably by the CS or IT Department. Scheme for the B.Tech Electronics and Telecommunication Engg.
C2	<p>New Syllabus of subject</p> <p>(i) "Analog and Digital Communication" for the B.Tech Electronics and Instrumentation Engg. 3rd year is approved. Experts suggested that the prerequisite required for the syllabus should be covered for its well understanding. The syllabus of the same subject is enclosed hereby</p> <p>(ii) 'Cellular and Wireless Networks' for the B.Tech Electronics and Instrumentation Engg. 3rd year is approved. Syllabus of the same subject is enclosed with the minutes.</p> <p>(iii) 'Digital Signal Processing' Electronics and Instrumentation Engg. 3rd year is Passed. Experts suggested that the knowledge of random theory, linear optimization, estimation theory is required as essential part without this, the unit number 5 cannot be covered effectively. Modified syllabus for the same subject is enclosed with the old syllabus.</p>
C3	The minor changes in the syllabus of 'Mobile Communication' for the B.Tech 3 rd yr. Elx. & TC Engg. have been approved.
C4	In discussion of inclusion of applications of AI and ML, in the core subjects of UG and PG course, the experts emphasized that the subject AI and ML should be a compulsory subject in the scheme of Elx. & TC Engg. courses. Also they suggested that identify the subjects in which the specific applications of AI and ML can be justified. AO and ML based applications in the subjects, perquisites of AI and ML should be satisfied, both for the students and the teachers as well. Experts have suggested that the classwork marks in which out of 30, the project work of that particular subject should cover 15 marks in which the project based on the AI and ML can be assigned to the students. The learning of python programming should be made compulsory to the students.
C5	<p>The matter of running, the PG course for working professionals was held in the meeting for which the experts' opinions were asked. The expert suggested the important points like the collaboration with the research agencies of Govt. of India like DRDO and ISRO.</p> <p>For the working professional, the expert raised the few points like distance between the research institute and their working industry etc. also the placement activity of undergraduate students should be monitored in the domains of core subjects for the future job perspective of placement of working professionals.</p> <p>The subject "EC24519 Digital Communication" of second year Computer Science Engg. has been discussed in which prerequisites required for the subject should be covered earlier. For prerequisites the discussion with the Department of Mathematics and the department of computer Science should be held or it should be included in the subject itself.</p>

	(I)	(i) Student application received for the permission to continue into 3 rd year despite low CGPA Resolution : It was informed to the house that an application from a student Daksh Verma (Enrollment No. 0801BM231017) was received, requesting that he having CGPA of 4.95 till 4th Semester and being below the required minimum of 5.0 CGPA to be promoted to III Year, as per RGPV norms. His application for relaxing this norm was forwarded to RGPV, Bhopal. The academic council expressed satisfaction and, till the instructions from RGPV is received, the institute's decision of allowing the student to attend the classes is ratified.

The Director shall serve as the final authority to make an appropriate decision on such matters.


	<p>(II) To apprise the house about List of Gold medals awarded to students, UDAAN - Graduation Day and Gold Medal distribution ceremony and Antyoday Diwas celebration - Announcement of Non-Government Scholarship.</p> <p>The Dean (ARSD) presented the list of Gold medals/Scholarships sponsored by various peoples /organizations for the students of SGSITS. The Gold Medal and Graduation ceremony is to be celebrated as "UDAAN" allowing the keshav purva chatra samanvay mandal of SSS as the main organizer. This year it is being celebrated on 08/Oct/2025, and from next year the date shall be decided based on the survey conducted and feedback taken from the current and pass-out students. The house was informed about the celebration of Antyoday Diwas on 25/Sept/2025, every year, as the birth anniversary of Pt. Deendayal Upadhyay. On this day the names of awardee of various scholarships shall be announced. The Council expressed satisfaction and approved the proposal.</p>
	<p>(III) AAROHAN – Techfest of the Institute</p> <p>It was informed to the house that the Vivekanand Navachar Manch of SSS is entrusted with the responsibility of organizing the Annual Techfest AAROHAN with the help of SIF, SAARTHI, other manch/mandals of SSS, and Vijayan Bharti New Delhi as the Knowledge Partner. Under AAROHAN-2025 various activities are being organized by different departments, and the concluding celebration will be held on 11th & 12th Oct. 2025. The Council expressed satisfaction and approved the proposal.</p>
	<p>(VI) 1st year Induction Programme (UDBHAV)</p> <p>In accordance with AICTE guidelines, the <i>UDBHAV</i> Induction Program for students is structured over a three-week duration, delivered in two distinct phases. Phase-I, conducted over four days, was aimed at familiarizing students with the institute, its environment, and academic culture. Additionally, a dedicated weekly time slot has been allocated throughout the semester to engage students in a variety of co-curricular and enrichment activities.</p> <p>Phase-II focuses on community service involving various reputed organizations preapproved by the Dean(ARSD), which includes NCC/NSS and those activities of various manch/Mandal of SSS which are preapproved by the Dean(ARSD) on the recommendations of Prof. Incharge (SSS). The students must participate in more than 75% of the assigned outreach and service-oriented initiatives. Upon successful participation, students shall be awarded three academic mandatory credits (LTP= 0:2:1) under the course named as <i>UDBHAV</i>. The committee constituted in agenda item no. 2 above should take a call if the credits for <i>udbhav</i> course should be included in the 160 credit requirement or it should be over and above the said requirement of B.Tech. program.</p>
