At the outset the Chairman welcomed all the members.

The deliberations of the meeting are summarized below:

1. Item No. 1: Regarding Undergraduate Programs w.e.f. Session 2023-2024.

A discussion was held among B.O.S. Members and ~~for~~ changes were proposed in the various syllabi of U.G. subjects as mentioned below:

1. The content of syllabi of "Geodesy" (CE21002) in III semester is proposed to be modified to the extent of 10%. The existing and proposed syllabus is enclosed for approval. (Annexure I/01)
2. The content of syllabi of "Material Technology" (CE21004) in III semester is proposed to be modified to the extent of 10% and proposed to be renamed as "Engineering Material". The existing and proposed syllabus is enclosed for approval. (Annexure I/02)
3. The content of syllabi of "Engineering Geology" (CE21508) in IV semester is proposed to be modified to the extent of 10%. The existing and proposed syllabus is enclosed for approval. (Annexure I/03)
4. Name of CE41499 "Major Project Phase-I" is proposed to change as "Minor Project" and Name of CE41998 "Major Project Phase-II" is proposed to change as "Major Project". This is in new point of possibility of working on two different topics and covering the project by focusing in this one relevant only. (Annexure I/04)

2. Item No. 2: Regarding Post Graduate Programms w.e.f. Session 2023-2024.

1. M. Tech. Environmental Engineering

1. In the I semester of M. Tech. Environmental Engineering, minor changes have been proposed in the syllabus of the Elective-I subject "Air Pollution and Control Technology" (CE59253). In the first

unit, the effect of air pollutants on human beings etc. has been added which is shifted from Unit 5. Also in Unit 3, the latest dispersion models in brief has been added and lastly gases and vapors control devices are added in Unit 5 from which effect of air pollutants is shifted to Unit 1. Accordingly, Course Outcome has been modified. The existing and proposed syllabi are attached for approval. (Annexure II/01)

2. In the I semester of M. Tech. Environmental Engineering, minor changes have been proposed in the syllabus of the Elective-II subject "**Hydrology, Applied Hydraulics & Ground Water**" (CE59351). The existing and proposed syllabus is enclosed for approval. (Annexure II/02)
