3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program have been granted accreditation for further 3 years. **Shri G.S. Institute of Technology & Science, 23, Visvesvaraya Marg (Park Road), Indore, Madhya Pradesh- 452003** should submit fresh online application under Tier I SAR January 2016 document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Shri G.S. Institute of Technology & Science, 23, Visvesvaraya Marg (Park Road), Indore, Madhya Pradesh- 452003** as a whole.
