to follow the terms and conditions laid down by the Govt. of India, AICTE, New Delhi in regard to
payment of Scholarship for M.E./M.Tech./M.Pharma students in Engg. & Technology some of which are
specified as under :-

1. I, undertake to engaged 8 to 10 hours (per week) of work related to teaching and research activities as assigned to me by the Institute which include tutorials, laboratory classes, development and maintenance of laboratories, assistance in research and development activities undertaken by faculty members, maintenance and operation of computers and other central facilities, assistance in Library etc.
2. I, undertake to provide assistance in Projects funded by Govt. of India/Univ. Grants Commissions/Council of Scientific & Industrial Research/Industry Sponsored Projects etc.
3. I am fully aware that Scholarship will be given to the students only for one year if he/she fails in first or second semester. However, for any entitlement of scholarship I shall abide by the existing AICTE rules.
4. I, understand that I shall be eligible for above scholarship of Rs.12,400/-p.m. for fourth semester only if the thesis/project supervisor is satisfied with the progress in 3rd Semester.
5. I, hereby undertake that I would not leave the course midway or appear in any competitive examination etc. not related to the Engineering /Technology. If, I leave the course midway on my own or if the Institute discontinues my studies due to poor performance in the course work including the negligence in duties as assigned to me, I shall return the entire amount of Scholarship paid to me till that time.
6. I, further undertake that during the course of studies, I shall not accept any employment and I shall not receive any emoluments, salary, stipend etc. from any other sources.
7. I shall return any amount, which is paid in excess to me for which I am not eligible.
8. In all cases of discrepancies the decision of the Director of the Institute shall be final and binding on me.
9. I, undertake to abide the conditions as deemed necessary from time to time by AICTE.
