The deliberations of the meeting after welcome of the members and the opening remarks of Chairman and Secretary are as under:-

Item No.1 - To confirm the minutes of the TEQIP BoG meeting No.6 dated 24.12.2020

- 2. Qualification upgradation of staff.
- 3. Support to Ph.D. Scholars / Faculty Members for R&D
- 4. Fee of NPTEL / SWAYAM Courses.
- 5. Exit exam training to students (GATE 2021).
- 6. Completion of remaining procurement activities.
- 7. NBA preparation for 1 UG and 4 PG courses (SAR uploaded).
- 8. Employability skill training to students.
- 9. To prepare the Institute as per the NEP guidelines. Three workshops were organized for faculty and students. Suggestions were sought regarding implementation of NEP.

Item No. 4 - To discuss the matter of sustaining the activities initiated under TEQIP – III.

The matter of sustainability of the activities initiated through TEQIP funds for the enhancing the standing of the Institute was discussed. The members suggested that:-

- (a) Project proposals be submitted to various funding agencies for continuing some of the ongoing activities.
- (b) Institute should be ready with a similar project proposal covering all the good practices under TEQIP for submission of the same to funding agencies.
- (c) Institute should make a provision for salary of TEQIP office staff for continuation as required for post project activities for next 6 months, if the same is not disbursed by NPIU.
- (d) Members stressed for a self-sustainable model for CIDI so as to meet the salary of staff and running expenses. However, till such sustainability is achieved, Institute should make a provision for the same through sustainability funds after obtaining necessary approvals.

Item No.5 - Any other item with the permission of the Chair

Prof. D. B. Phatak stressed the need of continuing the activities being carried out for enhancing the Institute standing even in the absence of funding through TEQIP like projects. He suggested to prepare a road map of the Institute in light of New Education Policy.
